- Training of master trainers.
- Exercising the quality assurance checks.
- Validation of collected data and data analysis.
- Draft report formats and validation of final report of the consulting firm.

The successful candidate will be a senior professional with solid experience in public health sector at national and international level. Candidate will be selected on the basis of the following competencies:

### **Qualification & Experience:**

- Postgraduate Research degree in Public Health after MBBS from a recognized university; additional specialized qualification in survey design and implementation will be preferred.
- Minimum 10 years' experience in research and surveys focusing on Health sector.
- Should have a good knowledge and recognized experience of surveys design, sampling, questionnaire development and trainings.
- Previous experience of SARA or HFA will be preferred.

- A good working knowledge of data analysis software(s)
